- Need communication before an event occurs so we will know how things will be paid for?
- If club members are encouraged to attend events, who should pay?

**Lucy corrected my minutes by saying that Ray forcefully said there was no need for a task force since the Social Committee costs should be included in the inbound budget. Anything else would need permission from the board.
